Quick Lane Service Lead Marketing

FordDirect Quick Lane Service Lead Marketing program is a geo-targeted paid search service and website for your Quick Lane.

Quick Lane Service Lead Marketing is \$371 per month (plus state and local taxes), with \$185.50 being funded by Quick Lane and the remaining \$185.50 funded by the Dealer but also Enhanced Earnings Program Eligible.

Quick Lane Service Lead Marketing includes:

- Managed and shared paid search bidding strategy targeting in market customers for services such as Brakes, Battery, Tires and Oil Changes.
- Integration with Quick Lane Creative and Offers to make service "turn key".
- Coordinated alignment between Ad Copy and Website landing page to match experiences to searches (E.g. Brakes searches see brake coupons).
- Conversion focused website that prompts customer to take high intent actions such as Send to Mobile offers and Phone Calls.
- Individual landing page development and maintenance providing hours of operation, current offers, and a dedicated call tracking number, local when available.

By executing the agreement below, you agree that Ford Motor Company may invoice your open account for \$185.50 per month (plus state and local taxes). You may cancel this Agreement after 30 days have passed from the first day of the month following its execution date by providing FordDirect with 30 days notice.
